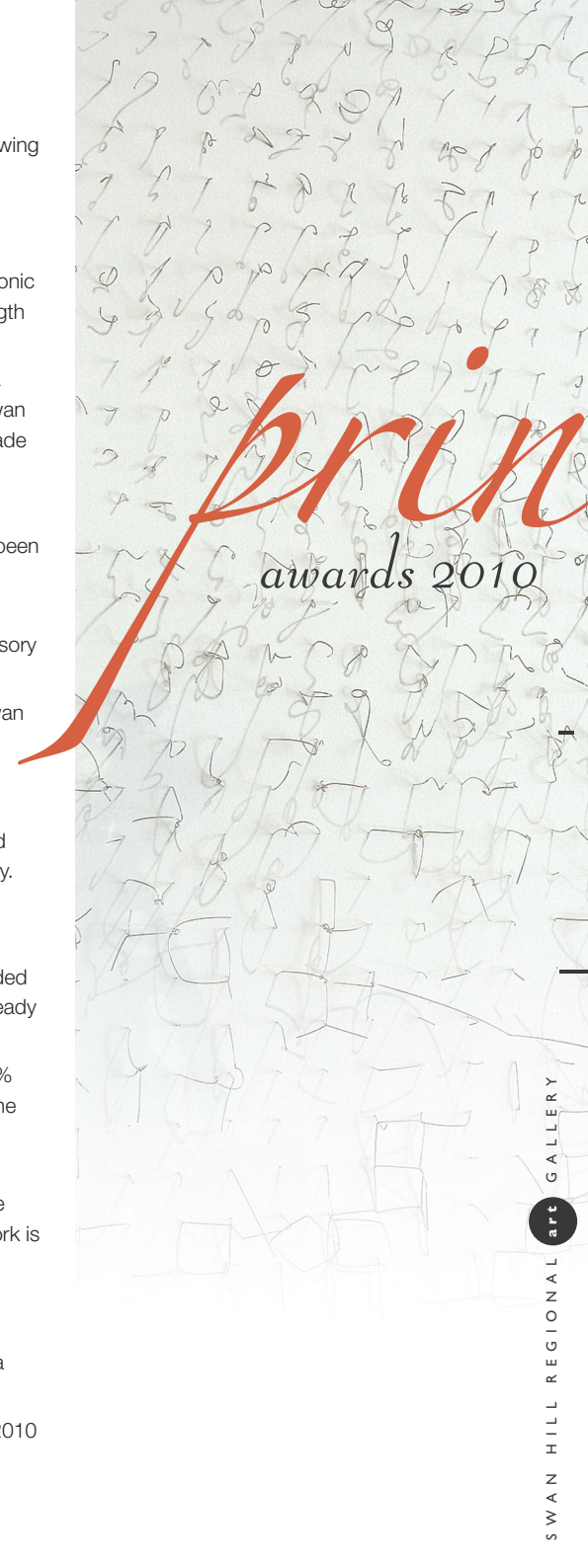

## conditions of entry

1. Artists from around Australia are invited to submit a print or drawing created after January 2008.
2. Images of one print and one drawing only per artist may be submitted for consideration by the judges.
3. All entrants must submit an entry form with a high quality electronic image of the work and a short written statement (maximum length of 50 words). Note: Slides or photographs will not be accepted
4. Images, statement about the work/s, a signed entry form and a non-refundable handling fee of \$25.00 per work must reach Swan Hill Regional Art Gallery by 5 February 2010. Cheques to be made payable to Swan Hill Regional Art Gallery.
5. Late entries will not be accepted.
6. All artists will be notified by 26 March 2010 whether they have been selected as a finalist or not.
7. Awards are not open to employees of Swan Hill Regional Art Gallery and members of the Swan Hill Regional Art Gallery Advisory Committee.
8. If selected, artists are responsible for delivering all work/s to Swan Hill Regional Art Gallery by 7 May 2010
9. Adequate protection must be taken in packaging work as no responsibility will be taken by Swan Hill Regional Art Gallery for damage or lost works during transit. Works of art will be insured whilst in storage and on display at Swan Hill Regional Art Gallery.
10. All works selected for the exhibition must be available for the duration of the exhibition, current from 14 May to 11 July 2010.
11. Instructions as to how work is to be installed needs to be included and if required, work should be suitably mounted and framed ready for exhibition.
12. Finalists' works must be available for sale. A commission of 20% will be retained by Swan Hill Regional Art Gallery upon sale of the artworks.
13. All finalists' works and statement about their work must be available for any form of media promotion and advertising of the exhibition. The Gallery will strive to ensure any publicity of artwork is appropriate.
14. Two awards will be given. One print and one drawing will be acquired by Swan Hill Regional Art Gallery. Selected artists will receive the value of their work and an additional amount up to a total of \$5,000.
15. Artists are responsible for the return of their artwork by 16 July 2010
